1 | Introduction

The RTW Loudness Tools are part of the RTW Masterclass PlugIns, an entirely new range of products that provides RTW meters as standard-format PlugIns for Windows[®] and Mac OS X[®]. RTW Loudness Tools feature Metering and Loudness display for mono, stereo, multichannel, and surround applications (8 channels max.) and all standard sampling rates up to 96 kHz. It supports all widely used PPM and TruePeak measurements and scales.

The RTW Loudness Tools run with VST 2.4 format for Windows[®] 7/8 (32/64 bit), and with RTAS format for Mac OS X[®] 10.6 or higher (others will follow). The setup files both are available from the member area of our web site (http://www.rtw.de/en/service/manuals-software.html -> Log-In -> "PC Software/RTW Loudness Tools"). An iLok USB smart key and a Pace iLok account is required for activation and copy protection.

This guide describes the installation on Windows $^{\ensuremath{\mathbb S}}$ 7/8 and Mac OS X $^{\ensuremath{\mathbb S}}$ in detail.

4 | Activation

The RTW Masterclass PlugIns Loudness Tools software requires an activation for the use without limitations. Therefore, PACE Anti-Piracy's iLok License Manager and a PACE iLok USB smart key for copy-protection have to be used. If you don't have these tools, please enter PACE iLok web site (http://www.ilok.com) to get them.



If you don't have an activation code yet, you are allowed to try the PlugIn for 14 days. Activation codes can be purchased from RTW.

For the following description we assume that you have an iLok USB smart key available.

1. Download **iLok License Manager** from the PACE iLok web site (http://www.ilok.com) and install it.



2. Create an iLok Account on the PACE iLok web site.

- 4. If you own an activation code, click Activate.



5. Enter the activation code.



6. Select the iLok USB smart key, to which the activation key will be stored.

7. If you don't have an activation code yet, click **Try** instead of Activate. You may use the RTW Loudness Tools as a 14 days trial.



8. Create an iLok Account and use an iLok USB Smart Key.

As a means for quality control, the RTW Loudness Tools with their precisely working and easy-to-read instruments ensure compliance with custom specifications. Thanks to intuitive operation, they are equally suitable for users with or without background knowledge.

The RTW Loudness Tools PlugIn provides the functionality of the award-winning TM7 and TM9 basic PPM instruments in combination with its loudness licence and offers the same degree of functionality and clarity as the hardware models. The instruments can be freely arranged and scaled. Various function parameters offer extra flexibility. Six selectable window frames (landscape and portrait view) permit the tailorable positioning of the provided instruments. Multiple instances may be used. You can store all setups and layouts as presets in your DAW.

Although you may operate the PlugIn's instruments intuitively, tool tips in the menus will give you assistance for your individual settings. If you move the mouse accross an option, a short description of its functionality is displayed.
